- 2. Private Practice of any kind whatsoever is prohibited.
- 3. The regularization shall carry with it the liability to serve in any part of Himachal Pradesh.
- 4. The regularization will be further subject to production of following certificates/declaration as under:
 - a. Certificate of Medical fitness issued by the District Medical Board.
 - b. A declaration to the effect that the appointee had not/shall not have more than one living spouse/shall not marry a person who has living spouse.
 - c. Taking an oath of allegiance/ faithfulness to the Constitution of India or making a solemn affirmation.
 - d. The above officers shall have to produce the following original certificates to DAO/SDAMO respectively for verification and making entries of Regularization in the service book:-
 - I. Degree/Certificate(s) of Educational and professional qualifications.
 - II. Certificate of age alongwith a copy of Matriculation certificate passed from a recognized Board/ University.
- 5. The regularization is subject to the character and antecedents of the candidate being found satisfactory on verification.
- 6. The above officers on their regularization shall continue to work at their present place of posting.

If the concerned officers accepts the offer of regularization on above terms and conditions, should report for duties at the respective place of posting and submit their joining report to this department through proper channel within ten days from the date of issuance of this notification.
